Our projects/studies are conducted following our compromise with the 3R's:

- **Replace** the use of animals with alternative techniques, or avoid their use altogether.
- **Reduce** to obtain comparable levels of information from the use of fewer animals. With strategies such as appropriate experimental design, correct statistical evaluation, and sharing resources and/or animals.
- **Refine** the husbandry and experimental procedures in order to minimize or eliminate animals' pain and distress and improve their welfare. Including, within others, anaesthetics and analgesics, humane animal handling, environmental enrichments, and humane endpoints.

Regulatory compliance

Our commitment with GLP (Directive 2004/9/CE) & ISO13485 (UNE EN ISO 13485:2018 + /A11:2021 (EN ISO 13485:2016 +/AC:2018 + /A11:2021) & UNE EN ISO 9001:2015 is to guarantee the uniformity, consistency, traceability reliability, reproducibility, quality and integrity of non-clinical projects / studies performed or led by SPECIPIG.

As our team is our main value, our commitment is focused in offering the best environment, tools and training for their personal engagement and professional development.


Business focus
